BE IT RESOLVED, by the Council of The City of San Diego that the low bids of 1. TALIN TIRE, INC. and 2. DANIELS TIRE SERVICE, meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute contracts for furnishing the City of San Diego and the San Diego Unified School District with RECAPPING OF PASSENGER & TRUCK TIRES as may be required for a period of one (1) year beginning August 1, 1988 through July 31, 1989, per prices on file in the Purchasing Department, as follows:

1. TALIN TIRE, INC. for Schedule II - Medium Duty Truck Tires; Schedule III - Heavy Duty Truck Tires; and Schedule V - Fire Department Truck Tires, for a total estimated cost of \$122,310.00; terms 1% 20 days, plus sales tax; with an option to renew contract for an additional one (1) year period, with price escalation not to exceed 10% of bid prices.
2. DANIELS TIRE SERVICE for Schedule IV - Off-Road Tires, for a total estimated cost of \$7,247.68; terms net 10 days, plus sales tax; with an option to renew contract for an additional one (1) year period, price escalation not to exceed 7-1/2% of bid prices.
