BE IT FURTHER RESOLVED, that the proposed easement for sewer, water, gas, electrical, telephone and cable television, across

Lot 2 for the benefit of Lot 14 of the final map of SCRIPPS RANCH

BUSINESS PARK PHASE III, is hereby approved.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portions of public streets are accepted on behalf of the public as heretofore stated; together with the easements with the right of ingress and egress for the construction and maintenance of water and drainage facilities, and slopes, as well as the building restricted easement, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
