Robert Tobias	Water Utilities	180.00	Mr. Tobias is a Waste Water Plant Operator with the Metro Division. He suggested the use of a 2" PVC drain pipe in the odor tower scrubber tank to prevent plugging. Although savings are difficult to identify, this was considered to be a significant operational improvement.
David Buck	Fire	\$160.00	Mr. Buck is a Captain. He suggested requiring contracting alarm companies to supply all special keys and tools needed to reset involved alarms. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Eugene Forcier	Risk Management	\$80.00	Mr. Forcier is a Claims Representative with the Worker's Compensation Division. He suggested the modification of Worker's Compensation computer print out for daily diaries to include a column for lost time or medical only. Although savings are difficult to identify, this was considered to be a significant operational improvement.
