ADOPTED ON JUL 25 1988

WHEREAS, on September 21, 1987, the Council of the City of San Diego adopted Council Policy 900-6 on Solid Waste recycling; and

WHEREAS, said policy established a goal of recycling a minimum of 25% of the solid wastes generated annually within the City by July 1992; and

WHEREAS, the Council directed the City Manager to prepare a comprehensive recycling plan to achieve the City's recycling goal; and

WHEREAS, the City Manager has prepared and submitted the City of San Diego Recycling and Waste Reduction Plan 1988-1992; and

WHEREAS, said Plan has received wide distribution and a public hearing was held on July 6, 1988 to receive public input and testimony and that testimony has been considered and incorporated as appropriate into said Plan; and

WHEREAS, the City Manager has prepared City Manager's Report No. 88-344 which recommends approval of said plan; NOW,

THEREFORE,

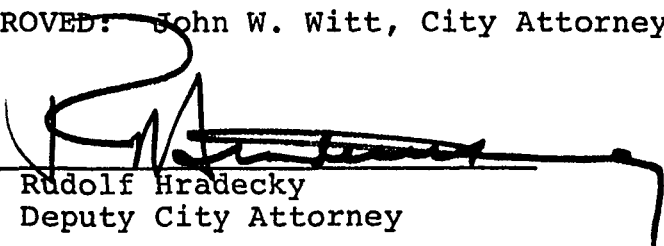
BE IT RESOLVED, by the Council of The City of San Diego, as follows:
