ADOPTED ON JUL 25 1988

WHEREAS, the Greater North Park Community Planning Committee ("Planning Group") has been recognized by the Council of The City of San Diego ("Council") as the official community planning committee for the Greater North Park planning area; and

WHEREAS, the Planning Group's bylaws were most recently revised by the Council on July 29, 1984, in order to refine the administrative procedures of the Planning Group; and


WHEREAS, the Planning Group has amended its bylaws to clarify the purpose and intent of the Planning Group, expand the qualification requirements for membership and board membership, amend the voting requirements, amend the requirement for qualification of office, clarify the duties of officers, amend the date for noticing and election of officers and board members, reduce the terms of office for board members, specify the procedures for amending the bylaws and other administrative changes; and

WHEREAS, the recommended amendments were reviewed and adopted unanimously by the Rules Committee on July 6, 1988, and are now forwarded to the full Council for appropriate action; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendation contained in Planning Department Report No. 88-138 dated June 10, 1988, to adopt the amended bylaws

for the Greater North Park Community Planning Committee, a copy of which is on file in the office of the City Clerk as Document No. RR- 271502, be and the same is hereby approved and adopted.
