


RESOLUTION NUMBER R- 271507

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a first amendment to sublease agreement with SAN DIEGO DATA PROCESSING CORPORATION, which amendment extends the term of the sublease agreement to November 30, 1989, for the use by the City's Risk Management Department of 7,653 square feet of office space in the Security Pacific National Bank Building , under the terms and conditions set forth in that first amendment to sublease agreement on file in the office of the City Clerk as Document No. RR- 271507.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$141,000 from Risk Management Revolving Fund 50061 for lease costs from July 1, 1988, through June 30, 1989, is hereby authorized and approved.
