
ADOPTED ON JUL 25 1988

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to encumber an amount not to exceed \$600,000 for the purchase of said insurance for the period of July 1, 1988 through June 30, 1989.
