RESOLUTION NUMBER R- 271532

ADOPTED ON JUL 26 1988

WHEREAS, AB 2595 (Sher) would enact the California Clean Air Act of 1988 to create a mandate for nonattainment areas to meet State ambient air standards by the earliest practicable date; and

WHEREAS, the measure contains desirable provisions such as an approach to deal with the problem of air pollution transport, but it also contains provisions which grant authority for transportation control measure planning to the air pollution control districts without specifying that there is infringement upon the local land use authority of cities and counties; and

WHEREAS, in 1978, after local agreement upon a cooperative process was reached, the California Air Resources Board designated the San Diego Air Pollution Control Board and SANDAG as co-lead agencies within the San Diego region for transportation control measure planning; and

WHEREAS, the Council of The City of San Diego adopted Resolution No. R-250955 on January 7, 1980 which expressed support for the co-lead designation; and

WHEREAS, the League of California Cities has proposed to amend AB 2595 to clarify that the local land use authority of cities and counties will be preserved; and


WHEREAS, the Intergovernmental Relations Department Report No. 88-24 was reviewed by the City Council on July 26, 1988; and

WHEREAS, said report proposes that AB 2595 be opposed unless amended and sets forth proposed amendments; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendations contained in the Intergovernmental Relations Department Report No. 88-24 to oppose AB 2595 (Sher) unless it is amended as specified above is hereby adopted.
