

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an amended group health insurance agreement with Kaiser Foundation Health Plan, Inc., a copy of which is on file in the office of the City Clerk as Document No. RR-271557, for all eligible employees not represented by the San Diego Municipal Employees Association, to extend the agreement for a one-year period beginning August 1, 1988 through July 31, 1989 and to increase the premium rates as follows:
