BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to the River Run Participation Agreement with the RIVER RUN CLUB, LIMITED AND PUEBLOS DEL RIO NORTH, LIMITED, to provide additional funding of \$185,218.73 to perform the work associated with the North Mission Valley Interceptor Sewer (CIP No. 43-033.0), under the terms and conditions set forth in the First Amendment to the River Run Participation Agreement on file in the office of the City Clerk as Document No. RR- 271563 .

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$185,218.73 from the Sewerage Utility Revenue Fund (41506), CIP No. 43-033.0, North Mission Valley Interceptor Sewer, to supplement funds previously authorized by Resolution RR-270229, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
