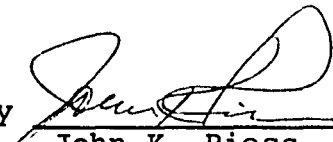

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$160,900.51 from C.I.P. 53-035, Ingraham Street Bridge Over Mission Bay Channel, is hereby authorized, solely and exclusively for the purpose of funding this change order.

BE IT FURTHER RESOLVED that the City Auditor, upon advice from the administering department, is hereby authorized to transfer excess funds, if any, to the appropriate reserve.
