WHEREAS, the City has previously considered and agreed to the concept of joining in a consortium with other coastal cities to ensure the environmental impacts of the proposed federal oil and gas leases offshore are fully understood; and

WHEREAS, the City of Santa Cruz has taken the lead role in providing an Oil Information Program to provide information on said impacts; and

WHEREAS, as its share of consortium costs, The City of San Diego has been requested to contribute the sum of \$1,500, to assist in the support of the Oil Information Program; and

WHEREAS, it is also appropriate to execute an agreement with the City of Santa Cruz for said purpose; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the expenditure of \$1,500 from the General Fund 100, Unallocated Reserve (605) as the City's share of consortium costs in the City of Santa Cruz's "Oil Information Program" be and the same is hereby authorized.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of The City of San Diego, an agreement with the City of Santa Cruz pertaining to the funding of the "Oil Information Program," pursuant to the terms and conditions of the agreement,
