ADOPTED ON AUG 02 1988

WHEREAS, on August 2, 1988, the Council of The City of San Diego held a public hearing for the purpose of considering an amendment to the Ocean Beach Precise Plan and Local Coastal Program Land Use Plan; and

WHEREAS, the proposed amendment to the Ocean Beach Precise Plan and Local Coastal Program Land Use Plan will result in the redesignation of properties located south of Del Monte Avenue, north of Pescadero Avenue, east of Ebers Street and west of Froude Street as more particularly shown on Attachment 1, from Residential 8-14 du/nra to Single-Family Residential 0-9 du/nra; and

WHEREAS, the Council finds the proposed amendment consistent with the Progress Guide and General Plan of The City of San Diego; and



implementation after full and effective certification by the California Coastal Commission, and directs and authorizes the Planning Director to transmit this amendment of the Ocean Beach Local Coastal Program Land Use Plan to the California Coastal Commission for final certification.

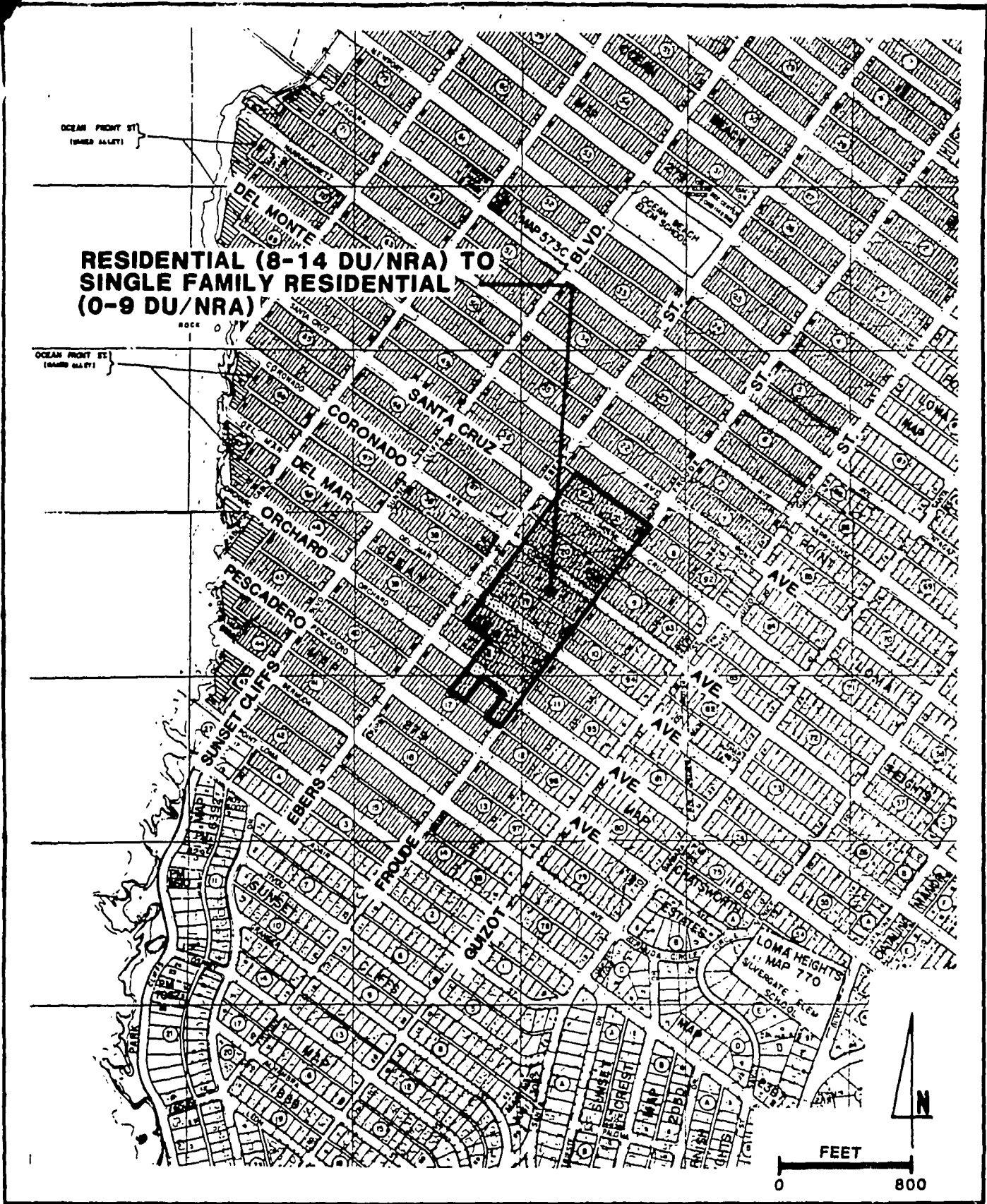
