WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and


WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

Donovan Jacobs	Police	\$5,000.00	Mr. Jacobs is a Police Agent. He suggested the revision of form PD88 (Supplemental Arrest Report-Narcotics/Drug Influence Case). Actual savings of \$115,083 in time has been realized. This is his full award.
James Froslic	General Services	\$2,073.12	Mr. Froslic is a Service Writer with the Equipment Division. He suggested replacing the mechanical back up bell on trash trucks with an electrical alarm. Estimated savings of \$13,830.80. This is a partial award pending a 12-month review.
Jim VanNorman Chuck Hartje	Water Utilities	\$ 698.51	Mr. VanNorman and Mr. Hartje are Diver I's with the Production Division. They suggested simplifying the securing of the diving barge. Actual savings of \$2,328.37 in time has been realized. This is their full award.
