RESOLUTION NUMBER R- 271587

ADOPTED ON AUG 8 1988

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. Terminating the contract with JOSEPH HOHE ENTERPRISES, INC. for furnishing SECURITY GUARD SERVICE THROUGHOUT PENASQUITOS CANYON PRESERVE as may be required for a period of nine (9) months beginning July 1, 1988 through March 31, 1989; which contract was authorized by Resolution No. 271127, adopted on June 13, 1988.
2. Authorizing a contract with the second low bidder, HAYES SECURITY NETWORK for furnishing SECURITY GUARD SERVICE THROUGHOUT PENASQUITOS CANYON PRESERVE as may be required for the balance of the contract period from the date the contract with Joseph Hohe Enterprises, Inc. is terminated through March 31, 1989, at a cost of \$2,300.00 per month; terms net 30 days, with options to renew contract for four (4) additional one (1) year periods, with price escalations not to exceed four percent of prices in effect at the end of each year.
