BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for ORCHARD AVENUE STAIRS (PHASE 2), San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on AUG 8 1988, and bearing official Document No. U.D. 119194, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for ORCHARD AVENUE STAIRS (PHASE 2).

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$32,000 from Revenue Sharing Fund 18014, CIP No. 91-801.3 GENERAL REVENUE SHARING - GENERAL CONTINGENCY FUNDS and \$80,000 from Capital Outlay Fund 30245, CIP No. 90-245 CAPITAL OUTLAY FUND RESERVE - GENERAL - CONTINGENCY FUNDS to CIP No. 54-004 ORCHARD AVENUE STAIRS.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$123,492 from CIP No. 54-004 ORCHARD AVENUE STAIRS is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
