BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$220,957 (\$217,833 from PSD Fund 11361 and \$3,124 from PSD Fund 11360) from CIP No. 29-601 SAN CARLOS COMMUNITY PARK - IMPROVEMENTS is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
