BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF CHANNELIZATION IMPROVEMENT, AND TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT EL CAJON BOULEVARD AND FLORIDA STREET.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$113,900 from Capital Outlay Fund 30245, CIP No. 61-002 ANNUAL ALLOCATION - NEW TRAFFIC SIGNALS is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to retain excess budgeted funds, if any, in CIP No. 61-002 ANNUAL ALLOCATION - NEW TRAFFIC SIGNALS.
