APPROVING MAP OF MIRADOR PARK UNIT NO. 4.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Hans Peter Craig, Licensed Land Surveyor, entitled "MIRADOR PARK UNIT NO. 4 being a subdivision of a portion of Parcel 5 of Parcel Map No. 14629, according to map thereof filed in the office of the County Recorder of San Diego County January 15, 1987; a portion of Parcel 3 of Parcel Map No. 12882, according to map thereof filed in the office of the County Recorder of San Diego County September 2, 1983; and a portion of the Southwest Quarter of the Northwest Quarter of Section 25, Township 14 South, Range 3 West, San Bernardino Meridian, according to official plat thereof; all being in the City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Santa Armintha Avenue, Los Sabalos Street, Prairie Wood Drive, Herring Cove, and Lott Point, and said streets are hereby declared to be public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easement with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on the map within the subdivision.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; together with the easement with the right of ingress and egress for the construction and maintenance of drainage facilities, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
