BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of those street easement deeds of STAN KEISER, dated May 24, 1988; PARDEE CONSTRUCTION COMPANY, a California corporation, dated June 22, 1988; and MARGARET M. THORNBURGH and BARBARA THORNBURGH CARLTON (as co-trustees of that certain trust agreement executed on October 13, 1970,) dated June 20, 1988, all executed in favor of The City of San Diego, copies of which deeds are on file in the Office of the City Clerk as Document Nos. RR- 271608-1, RR- 271608-2 and RR- 271608-3, granting to said City easements for public street purposes in a portion of the North Half of Section 17, Township 14 South, Range 3 West, San Bernardino Meridian, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named LANSDALE DRIVE.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
