APPROVING MAP OF TIERRASANTA NORTE III

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Robert G. Schoettmer, Licensed Land Surveyor, entitled "TIERRASANTA NORTE III being a subdivision of a portion of Parcel 2 of Parcel Map No. 8547, in the City of San Diego, County of San Diego, State of California, according to map thereof filed in the Office of the County Recorder of said County, March 19, 1979, together with portions of Antigua Boulevard and Via Valarta as dedicated to public use, and together with portions of Via Maltaso, Via Septimo and Via Valarta as closed and vacated to public use by the recording of this map per Section 66499.20 1/2 of the California State Subdivision Map Act" is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

That said Council hereby accepts on behalf of The City of San Diego, the easements with the right of ingress and egress of emergency vehicles and for the construction and maintenance of water and general utility facilities as granted and shown on the map within the subdivision.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the building restricted easement over, upon or across Lot 1 as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map together with the easements with the right of ingress and egress of emergency vehicles and for the construction and maintenance of water and drainage facilities, as well as the building restricted easement, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
