APPROVING MAP OF TIERRASANTA NORTE VI UNIT
NO. 1.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Robert G. Schoettmer, Licensed Land Surveyor, entitled "TIERRASANTA NORTE VI UNIT NO. 1 being a subdivision of all of Lots 30 through 43 inclusive, 52 through 59 inclusive, and portions of Lots 22 through 29 inclusive, 48, 49, 50, 51, 60 and 61 of Villa Mesa Unit No. 2, according to map thereof No. 10186, filed in the office of the County Recorder of San Diego County, September 4, 1981; all of Lots 62 through 106 inclusive, of Villa Mesa Unit No. 3, according to map thereof No. 10187, filed in the office of the County Recorder of San Diego County, September 4, 1981; and a portion of Parcel 3 of Parcel Map No. 8547, according to map thereof filed in the office of the County Recorder of San Diego County, March 19, 1979; all in the City of San Diego, County of San Diego, State of California, together with portions of Antigua Boulevard and Villarrica Way as dedicated to public use, and together with Via Maltaso as closed and vacated to public use in accordance with the provisions of Section 66499.20 1/2 of the Subdivision Map Act, and together with the open space easements and general utility easements granted per

Map Nos. 10186 and 10187, as abandoned in accordance with the provisions of Section 66499.20 1/2 of the Subdivision Map Act," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Corte Playa Merida, Camino Playa Azul, and Camino Playa Carmel, and said streets are hereby declared to be public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the building restricted easement over, upon or across all of Lot 34, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said streets are accepted on behalf of the public as heretofore stated; as well as the building restricted easement, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
