
ADOPTED ON AUG 08 1988

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to renew, for and on behalf of said City, an agreement with the County of San Diego, Probation Department, to provide personnel to clean City-owned property, as may be required during the period from July 1, 1988 to June 30, 1989, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 269187.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$89,440 from Waste Management/Litter Control Budget, (Refuse Disposal Enterprise Fund) Fund No. 41200, is hereby authorized, solely and exclusively for the purpose of providing funds for the renewal of the above agreement and further authorizing the City Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
