- 1. That the City Manager be and he is hereby authorized to accept \$29,000 grant from U.S. Department of Housing and Urban Development (HUD) for the provision of emergency shelter services in the City of San Diego.
- 2. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a first amendment to the agreement with Episcopal Community Services, Inc., to continue the operation of the Emergency Shelter Program that provides temporary lodging for the homeless individuals in the San Diego area, under the terms and conditions set forth in the First Amendment to Agreement on file in the office of the City Clerk as Document No. RR- 271652.
- 3. That the expenditure of an amount not to exceed \$29,000 from Emergency Shelter Grant Funds, is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above first amendment to agreement and further authorizing the City Auditor and Comptroller upon advice from the

administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
