- 2. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an Agreement with United Way of San Diego County to operate the Community Shelter Program, a program designed to provide shelter to homeless individuals during the cold/winter season, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 271655.
- 3. That the expenditure of an amount not to exceed \$5,000 from Human Care Services Special Fund (19661) and \$25,000 from Community Development Block Grant Fund 18524, Department 5664, Organization 6413, are hereby authorized, solely and exclusively for the purpose of providing funds for the operation of the Community Shelter Program.
