WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provide a procedure for the summary vacation of streets and public service easements by City Council resolution where a street has been superseded by relocation and is excess right-of-way no longer required for street purposes; and

WHEREAS, the abutting property owners have requested the vacation of the westerly excess portion of Daley Center Drive south of Aero Drive, in connection with Stonecrest (TM 87-0692), to facilitate development of their properties; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, it is necessary and desirable that the vacation be conditioned upon the issuance of permits for the necessary public improvements; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the westerly excess portion of Daley Center Drive south of Aero Drive, in connection with Stonecrest (TM 87-0692), as more particularly shown on Drawing No. 17244-B, on file in the

office of the City Clerk as Document No. RR- 271666-, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

- 2. That the resolution shall not become effective unless and until the required dedication and related permits for the necessary public improvements have been issued satisfactory to the City Engineer. In the event that the required dedication and necessary permits are not issued within three (3) years from adoption of this resolution, this resolution shall become void and be of no further force or effect.
- 3. That the City Engineer shall advise the City Clerk of the approval of the aforementioned dedication and issuance of permits, and that the City Clerk shall then cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.




