APPROVING MAP OF TIERRASANTA NORTE VI UNIT  
NO. 2.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Robert G. Schoettmer, Licensed Land Surveyor, entitled "TIERRASANTA NORTE VI UNIT NO. 2 being a subdivision of all of Lots 1 through 13 inclusive, of Villa Mesa Unit No. 1, according to map thereof No. 10185, filed in the Office of the County Recorder of San Diego County, September 4, 1981; all of Lots 14 through 21 inclusive, 44 through 47 inclusive, and portions of Lots 22 through 29 inclusive, 48 through 51 inclusive, 60 and 61, of Villa Mesa Unit No. 2, according to map thereof No. 10186, filed in the Office of the County Recorder of San Diego County, September 4, 1981; and a portion of Parcels 2 and 3 of Parcel Map No. 8547, according to map thereof filed in the Office of the County Recorder of San Diego County, March 19, 1979; all in the City of San Diego, County of San Diego, State of California, together with a portion of Antigua Boulevard as dedicated to public use, and together with Via Maltaso and Via Septimo, as closed and vacated to public use in accordance with the provisions of Section 66499.20 1/2 of the Subdivision Map Act, and together with the open space easements and the general

utility easements granted per Map Nos. 10185 and 10186, as abandoned in accordance with the provisions of Section 66499.20 1/2 of the Subdivision Map Act," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

That said Council hereby accepts on behalf of The City of San Diego, the easements with the right of ingress and egress of emergency vehicles and for the construction and maintenance of water and general utility facilities, as granted and shown on the map within the subdivision.

That said Council hereby accepts on behalf of The City of San Diego, the building restricted easement over, upon or across Lot 1, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map; that the easements with the right of ingress and egress of emergency vehicles and for the construction and maintenance of water and general utility facilities, as well as the building restricted easement, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
