
RESOLUTION NUMBER R- 271680

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a Fourth Amended prepaid dental insurance Agreement with Safeguard Health Plan, Inc., to (1) extend the agreement for a two-year period beginning August 1, 1988 through July 31, 1990, the second year contingent upon funding thereof in the FY "90 appropriation ordinance, (2) add a \$20 copayment for emergency service, (3) provide split family enrollment (4) provide sealants at no charge; all as more particularly described in the Fourth Amended Agreement, which is on file in the in the office of the City Clerk as Document No. RR- 271680, and to establish the following premium rates as follows:


