RESOLUTION NUMBER R- 271686

ADOPTED ON AUG 08 1988

WHEREAS, there were relinquished to The City of San Diego certain abutters' rights of access in and to Rancho Bernardo Road adjacent and contiguous to Lot 14 of Bernardo Town Center Unit No. 5, Map 7601; and

WHEREAS, the Engineering and Development Department has requested that the City revest these access rights in the property to the UNITED STATES POSTAL SERVICE AND ITS ASSIGNS to allow better utilization of the land; and

WHEREAS, said abutters' rights of access are no longer needed by the City and should be revested in the property; and

WHEREAS, it has been determined that all affected City departments have no objection to the revestment of said abutters' access rights; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; and


WHEREAS, the City Manager recommends that said access rights be revested in the property; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 271686,

quitclaiming to the UNITED STATES POSTAL SERVICE AND ITS ASSIGNS, effecting the revestment of those abutters' rights of access in and to Rancho Bernardo Road adjacent and contiguous to said Lot 14 of Bernardo Town Center Unit No. 5, Map 7601, heretofore relinquished to the City, as more particularly described in the quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to deliver the deed and a certified copy of this resolution, attested by him under seal, to the Property Department for further handling.
