WHEREAS, the Rules Committee discussed Council Policy 300-8, entitled "Procedure for Confirmation of Appointment of Chief of Police" at its regularly scheduled meeting of August 3, 1988; and

WHEREAS, it was decided as a result of said discussion that the Policy should be amended to provide that confirmation criteria be established by the Council Committee of the Whole rather than the Public Services and Safety Committee; and


WHEREAS, it is now necessary to forward the matter to the full Council to approve said amendment to Council Policy 300-8 to eliminate all references to PS&S and include in-lieu therein the Council Committee of the Whole; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Council Policy 300-8, entitled "Procedure for Confirmation of Appointment of Chief of Police," dated December 17, 1975 be and the same is hereby amended by deleting therefrom under POLICY and in Attachment "A," thereto all reference to the "Public Services and Safety Committee" and including in-lieu thereof the "Council Committee of the Whole."

BE IT FURTHER RESOLVED, that the City Clerk be and he is hereby directed to make such change to Council Policy 300-8, incorporate said amended Policy in the Council Policy manual and

make distribution of the amended Council Policy 300-8 as is required.
