WHEREAS, the Rules Committee, on August 3, 1988, reviewed Intergovernmental Relations Report No. 88-27, dated July 28, 1988, in which the Intergovernmental Relations Department recommended approval for consideration at the League of California Cities Annual Conference in San Diego on October 16 through October 19, 1988, two resolutions relating to bans on ticket scalping and a recycling policy; and
