RESOLUTION NUMBER R-271704

ADOPTED ON AUGUST 9, 1988

WHEREAS, the City Council, on August 8, 1988, approved the assignment of the Downtown Marketing consortium ("DMC") under the direction and control of the Mayor's office; and

WHEREAS, said delineation of control carried concurrently the authority to direct and control the expenditure of funds appropriated for the conduct of the DMC program; and

WHEREAS, it is now requested that the sum of \$2,880.20 from said DMC appropriation be set aside to augment the Central City Association's "Taste of Downtown" event to be held on September 19, 1988; and

WHEREAS, said expenditure is in keeping with the purpose for which the DMC's program was formulated; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Auditor and Comptroller be and he is hereby fully authorized to set aside, allocate and expend a sum not to exceed \$2,880.20 from the funds appropriated for the Downtown Marketing Consortium to augment the Central City Association's "Taste of Downtown" event to be held on September 19, 1988, pursuant to the recommendation of the DMC's Executive Committee.
