RESOLUTION NUMBER R- 271718

ADOPTED ON AUG 9 1988

WHEREAS, the Department of Transportation, FAA Western-Pacific Region issued a "Determination of No Hazard to Air Navigation" on July 21, 1988 in regard to the Laurel Travel Center and parking structure on Laurel Street and Kettner Boulevard; and

WHEREAS, the report identifies the structure as an obstruction but concludes that with installation of additional safeguards, it does not have a substantial adverse effect upon the safe and efficient utilization of navigable airspace and is not a hazard to air navigation; and

WHEREAS, the conclusions reached in said determination letter set forth the factors of hazard but do not reach the conclusion warranted by the factors specified; and

WHEREAS, it is deemed most appropriate that the determination be appealed by The City of San Diego, an interested party; and


WHEREAS, it is necessary to file a petition for review on or before August 21, 1988 in order to perfect the City's rights in this matter; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Attorney and City Manager are hereby directed to appeal the written decision set forth in the the FAA's "Determination of No Hazard to Air Navigation," OE Number 88-AWP-769-OE, as it relates to the Laurel Travel Center Parking Structure, by filing

a petition for review on or before August 21, 1988 to the  
Manager, Flight Information and Obstructions Branch, ATO-210,  
Federal Aviation Administration, Washington, D.C. 20591.
