

RESOLUTION NUMBER R- 271723

ADOPTED ON SEP 06 1988

BE IT RESOLVED, by the Council of The City of San Diego that the low bids of 1. SAN DIEGO EQUIPMENT RENTALS, INC., 2. HERTZ EQUIPMENT RENTAL CORP., 3. BJ'S RENTAL STORE, 4. HAWTHORNE RENT-IT SERVICE, 5. U.S. RENTAL and 6. CASE POWER & EQUIPMENT, meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute contracts for CONSTRUCTION TYPE EQUIPMENT RENTALS UNOPERATED as may be required for a period of one (1) year beginning August 1, 1988 through July 31, 1989, per prices on file in the Purchasing Department, as follows:

1. SAN DIEGO EQUIPMENT RENTALS, INC. for Items 1, 3, 5 and 7 (Primary Contract); terms 1% 10 days, with options to renew contract for four (4) additional one (1) year periods, with option year price increases not to exceed prices in effect at the end of previous contract year by more than 10%.
2. HERTZ EQUIPMENT RENTAL CORP. for Item 2 (Primary Contract); terms net, plus applicable California sales tax.
3. BJ'S RENTAL STORE for Items 4, 8 and 9 (Primary Contract) and Item 7 (Secondary Contract); terms net, with options to renew contract for four (4) additional one (1) year periods, with price increases in the first two (2) option years not to exceed 6% of prices in effect at the end of previous contract year, and price increases in the last two (2) option years not to exceed 10% of prices in effect at the end of previous contract year.
4. HAWTHORNE RENT-IT SERVICE for Item 6 (Primary Contract) and Items 2 and 3 (Secondary Contract); terms net, plus applicable California sales tax, with options to renew contract for four (4) additional one (1) year periods, with option year price increases not to exceed prices in effect at the end of previous contract year by more than 10%.
5. U.S. RENTALS, located in Chula Vista, for Items 4, 6, 8 and 9 (Secondary Contract); terms 2% 20 days, with options to renew contract for four (4) additional one (1) year periods, with no price increases in the first option year and price increases in the last three (3) option years not to exceed prices in effect at the end of previous contract year by more than 5%.

6. CASE POWER & EQUIPMENT for Item 5 (Secondary Contract); terms net, plus applicable California sales tax.
