BE IT RESOLVED, by the Council of The City of San Diego that the low bids of 1. THOMAS TRUCKING, 2. BURNS & SONS TRUCKING, and 3. SUPERIOR CRANE & RIGGING, INC., meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute contracts for MISC. OPERATED SPOIL OR FILL TRUCK & LOWBOY TRAILER & TRACTOR RENTAL as may be required for a period of one (1) year beginning August 1, 1988 through July 31, 1989, per prices on file in the Purchasing Department as follows:

1. THOMAS TRUCKING for Item 1 (Primary Contract) and Items 2 and 3 (Secondary "Back-up" Contract); terms net, with options to renew contract for four (4) additional one (1) year periods, with no price increases other than those mandated by the PUC.
2. BURNS & SONS TRUCKING for Item 2 (Primary Contract) and Item 1 (Secondary "Back-up" Contract); terms net.
3. SUPERIOR CRANE & RIGGING, INC. for Item 3 (Primary Contract); terms net 30 days, with options to renew contract for four (4) additional one (1) year periods, with option year price increases not to exceed prices in effect at the end of previous contract year by more than 3%.
