BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT FOURTH AVENUE AND BEECH STREET AND AT INDIA STREET AND VINE STREET, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on SEP 06 1988, and bearing official Document No. W.O. 119055, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT FOURTH AVENUE AND BEECH STREET AND AT INDIA STREET AND VINE STREET.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$139,800 from Capital Outlay Fund 30245, CIP No. 61-002 ANNUAL ALLOCATION - NEW TRAFFIC SIGNALS is hereby authorized solely and exclusively for providing funds for said project and related cost, and authorizing the Auditor and Comptroller, upon advice from the administering department, to retain excess budgeted funds, if any, in CIP No. 61-002 ANNUAL ALLOCATION - NEW TRAFFIC SIGNALS.
