BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for LOMITA NEIGHBORHOOD PARK IMPROVEMENTS.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$15,375 (\$2,571 from PSD 11690, \$1,499 from PSD 11693, \$8,315 from PSD 15700 and \$2,990 from PSD 15701) from Park Service District Funds to CIP No. 29-466 LOMITA NEIGHBORHOOD PARK - IMPROVEMENTS.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$365,800 from CIP No. 29-466 LOMITA NEIGHBORHOOD PARK - IMPROVE-MENTS (\$47,425 from Park Service District Funds, \$180,000 from Revenue Sharing Fund 18013 and \$138,375 from Lomita Neighborhood Park Grant Fund) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to establish an interest bearing special fund entitled Lomita Neighborhood Park Grant Fund, for the receipt of Fiscal Year 1986 Roberti-Z'berg Harris grant monies in accordance with grant requirements, and that the City Auditor and Comptroller, upon receipt of grant funds from the Roberti-Z'berg Harris grant monies is hereby authorized to allocate these funds for the hereinabove described purpose.

BE IT FURTHER RESOLVED, that when Roberti-Z'berg Harris grant monies are received, Council will be requested to return funds to the Park Service District Funds from where they were transferred.
