
ADOPTED ON SEP 06 1988

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, secured agreements with the Baldwin Building Company which provide for the repair of specified portions of driveways within Carmel Valley Neighborhood 5, Units 2, 7 and 9 in the event that damage occurs attributable to the thickness of the concrete utilized in said driveways at any time within ten (10) years of the execution of the agreements, copies of which are on file in the office of the City Clerk as Document Nos.
