
BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That this Council accepts the sum of \$38,262 from Carmel Mountain Ranch pursuant to an agreement for the purpose of furnishings to the Carmel Mountain Ranch Fire Station, Fire Station No. 42, CIP Project 33-072 and authorizes the deposit of said sum to the credit of the said CIP Project 33-072.

2. That the expenditure of an amount not to exceed \$38,262 from Dept. 30244, is hereby authorized, solely and exclusively for the purpose of providing funds for the furnishings to the Carmel Mountain Ranch Fire Station, Fire Station No. 42, and further authorizing the City Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
