WHEREAS, in 1986, he was awarded an honorary Doctor of Education degree and was assigned as Commanding Officer of the Naval Training Center in San Diego; and


WHEREAS, his career, highlighted by several awards and decorations, will serve as a model for all who follow in his footsteps; NOW, THEREFORE,
