RESOLUTION OF THE CITY OF SAN DIEGO APPROVING
THE ASSURANCES AND CERTIFICATIONS UNDER THE
COMMUNITY PARKLANDS ACT OF 1986 FOR THE
FOLLOWING PROJECTS: REHABILITATION OF BALBOA
PARK CLUB, REHABILITATION OF FEDERAL BUILDING,
REHABILITATION OF MUNICIPAL GYMNASIUM

WHEREAS, the people of the State of California have enacted the Community Parklands Act of 1986, which provides funds to the State of California and its political subdivisions for acquiring and developing facilities for public recreational and historical purposes; and

WHEREAS, the State Department of Parks and Recreation has been delegated the responsibility for the administration of the program within the state, setting up necessary procedures governing application by local agencies under the program; and

WHEREAS, said procedures established by the State Department of Parks and Recreation require the applicant to certify by resolution the approval of required certifications and assurances; and


WHEREAS, the applicant agency will enter into an agreement with the State of California for acquisition, development, rehabilitation or restoration of the projects; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Council, having approved by resolution R-270183, dated January 19, 1988, the filing of an application for Community Parklands Act of 1986 state grant assistance for the above projects:

1. Certifies that The City of San Diego understands the assurances and certification in the application form; and
2. Certifies that The City of San Diego has or will have sufficient funds to operate and maintain the projects; and
3. Certifies that The City of San Diego will complete the projects within three years from the date of approval by the state.

BE IT FURTHER RESOLVED that the City Manager be appointed as agent of The City of San Diego to conduct all negotiations, execute and submit all documents including but not limited to applications, agreements, amendments, payment requests and so on, which may be necessary for the completion of the aforementioned projects.
