
RESOLUTION NUMBER R- 271775

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$16,008 from Fund No. 100, Dept. 535, Org. 231, is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above agreement and further authorizing the City Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
