BE IT RESOLVED, by the Council of The City of San Diego that the low bids of 1. COAST ELECTRIC CO., 2. ELECTRIC SUPPLIES DISTRIBUTING CO. (ESD), 3. GENERAL ELECTRIC SUPPLY, 4. GRAYBAR ELECTRIC COMPANY, 5. PACIFIC ELECTRIC SUPPLY, 6. SAN DIEGO WHOLESALE ELECTRIC CO., and 7.
