RESOLUTION NUMBER R-271860

ADOPTED ON SEPTEMBER 6, 1988

WHEREAS, Senate Bill 2896, relating to installation of fire sprinklers in buildings in California, has been presented to the Governor for signature; and

WHEREAS, the City Council on September 6, 1988 considered an ordinance amending the San Diego Municipal Code to require that all high rise buildings within the City be retrofitted with fire sprinkler systems; and

WHEREAS, it is the opinion of the legislative body of San Diego that the proposed fire protection and fire sprinkler ordinance is much more effective for San Diego; and

WHEREAS, after a thorough discussion concerning the matter, the City Council concluded that the Governor be requested to veto SB 2896 in view of the above recitals and the appropriateness for carrying forward the proposed fire protection and fire sprinkler law in San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby request and recommend that the Governor veto Senate Bill 2896.

BE IT FURTHER RESOLVED, that the Director of Intergovernmental Relations take all the necessary and appropriate action to inform the Governor and appropriate State

administrative officials of the San Diego City Council's request
and recommendation in this matter.
