RESOLUTION NUMBER R- 271861

ADOPTED ON SEP 19 1988

WHEREAS, there are thousands of San Diegans with a wide range of disabilities that include deafness, multiple sclerosis, epilepsy, muscular dystrophy, spinal injury and cerebral palsy; and

WHEREAS, disabled San Diegans struggle valiantly to live fulfilling lives, adjusting to their disability while working and accomplishing a great many things; and

WHEREAS, ten disabled support organizations have banded together to create "D*A*W*N," Disability Awareness Week Network, to reach out to the community and educate citizens on the proper etiquette when interacting with persons with disabilities, on the variety of disabilities facing many young San Diegans and facilitating the experience of a disabled person by inviting prominent San Diegans to experience a day as a disabled person; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that September 26 through 30, 1988 be proclaimed "Disability Awareness Week" in San Diego and urges all citizens to remember that a person who has a disability is first and foremost a person, but only one who happens to have a disability.
