

RESOLUTION NUMBER R- 271867

ADOPTED ON SEP 19 1988

BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF MECHANICAL WORKS PORTION OF THE HEATING, VENTILATING AND AIR CONDITIONING SYSTEMS FOR THE MUSEUM OF MAN LOCATED IN BALBOA PARK, San Diego, California, on SEP 19 1988, and bearing official Document No. W.O. 119187, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF MECHANICAL WORKS PORTION OF THE HEATING, VENTILATING AND AIR CONDITIONING SYSTEMS FOR THE MUSEUM OF MAN LOCATED IN BALBOA PARK.

BE IT FURTHER RESOLVED, that the contribution of \$38,000 from the Museum of Man to be used for the above purpose is hereby accepted.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller is hereby authorized to establish Fund Number 60257 for the purpose of depositing said contribution.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$100,000 (\$38,000 from Fund 60257, Account 9532 and \$62,000 from Fund 100, Department 532, Account 4213, Job Order 119187) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to General Services Department, Buildings Division, Fund 100.
