WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provide a procedure for the summary vacation of streets by City Council resolution where the streets to be vacated consist of a portion of a street or highway that lies within property under one ownership and that does not continue through such ownership or end touching the property of another, have been superseded by relocation, and are excess rights-of-way no longer required for street or highway purposes; and

WHEREAS, the abutting property owners have requested the vacation of Mission City Court, a street reservation, and the excess portions of Northside Drive, all within and adjacent to Mission City Unit 2, to facilitate development of their properties; and

WHEREAS, the streets to be vacated are not need for present or prospective public street purposes; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That Mission City Court, a street reservation, the slope easements appurtenant thereto and the excess portions of Northside Drive, as more particularly shown on Drawing No. 24549-D, on file in the office of the City Clerk as Document No. RR- $\frac{271869}{}$ , which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.
- 2. That the resolution shall not become effective unless and until a consolidation parcel map for the effected parcels has been approved by Council action. In the event that the consolidation map is not approved within three (3) years after adoption of this resolution, this resolution shall become void and be of no further force or effect.
- 3. That the City Engineer shall advise the City Clerk of the approval of the aforementioned consolidation parcel map, and that the City Clerk shall then cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.








RANCHO MISSION OF SAN DIEGO POR. LOT 36 MAP NO. 330 S.C.C. 348





RANCHO MISSIO POR, LOT 35 MAP


