

GRISSOM, dated February 12, 1988; and BARBARA WRUCK, dated February 11, 1988, all executed in favor of The City of San Diego, copies of which deeds are on file in the office of the City Clerk as Document Nos. RR-~~271877-1~~, RR-~~271877-2~~, RR-~~271877-3~~, RR-~~271877-4~~, RR-~~271877-5~~, RR-~~271877-6~~, RR-~~271877-7~~ and RR-~~271877-8~~, granting to said City easements for public street purposes in portions of Lots 1, 2 and 7, Section 4, Township 19 South, Range 1 West, San Bernardino Base and Meridian, and in Parcels 1, 2 and 4 of Parcel Map 5413, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for public streets, and the same are hereby named SIEMPRE VIVA ROAD and CACTUS ROAD.

under seal, to be recorded in the office of the County Recorder  
at no fee for the benefit of the City, with no documentary tax  
due.
