

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the City Heights Community Development Corporation, for certain economic development activities, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 271897 .

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed seventy-four thousand dollars (\$74,000) from Fund 18524, Dept. 5665, Org. 6502, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
