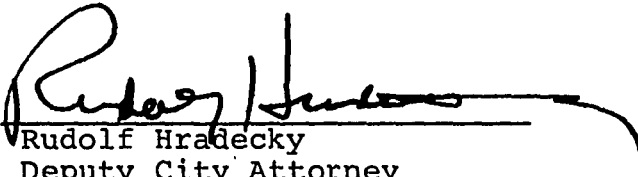

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a first amendment to the agreement with OMNICOM, INC., for the design and specification of a new Police Radio System, under the terms and conditions set forth in the First Amendment to Agreement on file in the office of the City Clerk as Document No. RR- 271898.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$40,546 (\$18,810 from CIP No. 36-046.0, Police Communications Upgrade for "Project B" and \$21,736 from CIP No. 33-069.0, Fire Department Support Services Complex), is hereby authorized, solely and exclusively to supplement funds previously authorized by Resolution No. R-268316 and further authorizing the City Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
